AN ACT

APPROPRIATING MONEYS TO THE DEPARTMENT OF HEALTH AND WELFARE FOR THE DIVISIONS OF MENTAL HEALTH SERVICES, PSYCHIATRIC HOSPITALIZATION AND SUBSTANCE ABUSE TREATMENT AND PREVENTION FOR FISCAL YEAR 2017; LIMITING THE NUMBER OF AUTHORIZED FULL-TIME EQUIVALENT POSITIONS; PROVIDING FOR GENERAL FUND TRANSFERS TO THE COOPERATIVE WELFARE FUND; DIRECTING EXPENDITURES FOR TRUSTEE AND BENEFIT PAYMENTS; PROVIDING LEGISLATIVE INTENT FOR PROGRAM INTEGRITY; LIMITING TRANSFER OF LEGISLATIVE APPROPRIATIONS; CLARIFYING RESPONSIBILITY FOR EDUCATION OF CERTAIN CHILDREN IN STATE CARE; DIRECTING AN INTERAGENCY PAYMENT FOR JUVENILE DETENTION CLINICIANS CONTRACT; PROVIDING LEGISLATIVE INTENT REGARDING A BEHAVIORAL HEALTH CRISIS CENTER LOCATION; PROVIDING LEGISLATIVE INTENT REGARDING FUNDING FOR THE IDAHO FALLS COMMUNITY CRISIS CENTER; AND PROVIDING GENERAL FUND REAPPROPRIATION FOR FISCAL YEAR 2016.

Be It Enacted by the Legislature of the State of Idaho:

SECTION 1. There is hereby appropriated to the Department of Health and Welfare, the following amounts to be expended according to the designated programs and expense classes, from the listed funds for the period July 1, 2016, through June 30, 2017:

27 SECTION 2. FTP AUTHORIZATION. In accordance with Section 67-3519,
 28 Idaho Code, each of the programs in the Department of Health and Welfare
 29 listed below is authorized no more than the number of full-time equivalent
 30 positions at any point during the period July 1, 2016, through June 30, 2017,
 31 unless specifically authorized by the Governor. The Joint Finance-Appropriations
 32 Committee will be notified promptly of any increased positions so
 33 authorized.

1 SECTION 3. GENERAL FUND TRANSFERS. As appropriated, the State Con-
2 troller shall make transfers from the General Fund to the Cooperative
3 Welfare Fund periodically, as requested by the director of the Department of
4 Health and Welfare and approved by the Board of Examiners.

5 SECTION 4. TRUSTEE AND BENEFIT PAYMENTS. Notwithstanding the provi-
6 sions of Section 67-3511, Idaho Code, funds budgeted in the trustee and
7 benefit payments expenditure class shall not be transferred to any other
8 expense class during fiscal year 2017.

9 SECTION 5. PROGRAM INTEGRITY. Notwithstanding any other provisions of
10 law, it is hereby declared to be the intent of the Legislature that the De-
11 partment of Health and Welfare shall be required to provide those services
12 authorized or mandated by law in each program, only to the extent of funding
13 and available resources appropriated for each budgeted program.

14 SECTION 6. LIMITING TRANSFER OF LEGISLATIVE APPROPRIATIONS. Notwith-
15 standing the provisions of Section 67-3511, Idaho Code, Cooperative Welfare
16 (General) Fund moneys appropriated to the Division of Mental Health and the
17 Psychiatric Hospitalization Division may be transferred between divisions,
18 but shall not be transferred to any other division or program within the De-
19 partment of Health and Welfare without legislative approval.

20 SECTION 7. LEGISLATIVE INTENT. It is the finding of the Legislature
21 that the Department of Health and Welfare is responsible for the educational
22 needs of school-age children placed in its custody by the courts for either
23 child protective or for mental health issues. If the Department of Health
24 and Welfare places a child in a licensed residential treatment facility that
25 includes a nonpublic accredited school, and it is determined by the Depart-
26 ment of Health and Welfare that it is in the best interest of the child to be
27 educated at the residential treatment facility, then it is the responsibil-
28 ity of the Department of Health and Welfare to pay for such education at the
29 rate of \$71.05 per student per educational day. This intent language does
30 not preclude other Idaho state agencies from exercising their responsibil-
31 ity to ensure a free and appropriate education for these students within the
32 requirements of federal disability law. The fiscal impact of this language
33 is approximately \$690,000 from existing appropriations.

34 SECTION 8. INTERAGENCY PAYMENT FOR JUVENILE DETENTION CLINICIANS CON-
35 TRACT. The Children's Mental Health Program shall, no later than July 16,
36 2016, make an interagency payment of \$327,000 from the Cooperative Welfare
37 (General) Fund to the Department of Juvenile Corrections to be used for the
38 purchase of contract clinician services with juvenile detention facilities
39 in Idaho, for the period July 1, 2016, through June 30, 2017.

40 SECTION 9. BEHAVIORAL HEALTH CRISIS CENTER LOCATION. It is the intent
41 of the Legislature that \$1,013,300 of the amount provided in Section 1 of
42 this act, for the Adult Mental Health Program, is for a Behavioral Health
43 Crisis Center, to be located in Health and Welfare Region 5. Further, it is
44 the intent of the Legislature that \$506,700 of the amount provided in Section

1 of this act, for the Adult Mental Health Program, is for a Behavioral Health
2 Crisis Center, to be located in Health and Welfare Region 4.

3 SECTION 10. IDAHO FALLS BEHAVIORAL HEALTH CRISIS CENTER. It is the in-
4 tent of the Legislature that the Behavioral Health Community Crisis Center
5 located in Idaho Falls, share its two-year plan, as required by contract with
6 the Department of Health and Welfare, that will demonstrate to what extent
7 the region will provide financial support from local sources for ongoing op-
8 erations of the center. The contractually required plan is to be submitted
9 to the Legislative Services Office no later than December 31, 2016. Fur-
10 ther it is the expectation that all other community crisis centers will be
11 required to share their two-year plan as required by their contract with the
12 Department of Health and Welfare upon completion of two years of operations.

13 SECTION 11. GENERAL FUND REAPPROPRIATION AUTHORITY. There is hereby
14 reappropriated to the Department of Health and Welfare for the Adult Mental
15 Health Program, up to \$715,000 of the unexpended and unencumbered balance of
16 Cooperative Welfare (General) Fund moneys as appropriated for fiscal year
17 2016, to be used for nonrecurring expenditures related to the implementation
18 of Behavioral Health Community Crisis Centers to be located in Health and
19 Welfare Region 4 and Region 5, for the period July 1, 2016, through June 30,
20 2017.
